An arrest, or the issuance of a citation, does not imply guilt

03/08/2015

An officer observed two females fighting near the intersection of Elm and Marshall Streets. Lilian Scott, 37 and Shavonda Williams, 24, both of Charleston, were arrested for public affray. Both were placed in jail.
